

THE RECTOR'S ORDER NO. 2/2021

TO TESTING UJEP STUDENTS FOR THE PRESENCE OF THE SARS-COV-2 VIRUS

According to the extraordinary measure of the Ministry of Health No. 21735/2021-1/MIN/KAN, 22. 05. 2021, the personal presence of students for education at the university is permitted from 24 May 2021, only if

- 1. the student does not have any symptoms of the COVID-19 disease,
- 2. once in 7 days, the student undergoes a preventive RT-PCR test for the presence of the SARS-CoV-2 virus or a preventive antigen test for the antigen determination of the SARS-CoV-2 virus with a negative result. The condition No. 2 does not refer to individual consultations and individual full-time teaching or any other individual activities.

The exceptions from testing have students who:

- had suffered a laboratory confirmed COVID-19 disease, their isolation period, according to the valid extraordinary measures of the Ministry of Health, had passed, have no symptoms of the COVID-19 disease, and since the first positive RT-PCR test for the presence of SARS-CoV-2 virus or POC antigen test, more than 180 days have not passed, or
- 2. have certificates about vaccination against the COVID-19 disease issued by the Ministry of Health and at least 14 days have elapsed since the second dose of the vaccine (in the case of double dose schedule, according to the Summary of Product Characteristics (SPC)), or at least 14 days have elapsed since the first dose of vaccine (in the case of the single dose schedule under the SPC), and the vaccinated person has no signs of the COVID-19 disease, or
- 3. underwent a RT-PCR test for the presence of SARS-CoV-2 virus, or the POC antigen test for the presence of the antigen of SARS-Cov-2 virus, at a health service provider included in the network of sampling centres with a NEGATIVE result, and the test is not older than 74 hours.

The testing of students starts on 26 April 2021 in the Purple Hall of the MFC building, the University Campus, Pasteurova 3544/1, Ústí nad Labem.

- UJEP students can make use the UJEP testing place. The testing takes place in the Purple Hall of the MFC building that will be marked with the inscription "Testing room for students". The premises of the Purple Hall have effective ventilation that will be provided throughout the testing.
- 2. The testing of students will take place in a weekly mode: Monday Friday, between 7:00 and 12:00.
- 3. The tested student will present the student's identification card and a valid health insurance card to the testing person who is professionally qualified to perform the test and state his/her name and surname. Subsequently, a professionally qualified person will perform a test.
- 4. Student has to wait for the test result that will be notified to him/her by the qualified person (approx. in 15 minutes). The information about test results will be passed to students in a paper form.

Procedure in case of the positive test result

- If the result of the preventive antigen test (at UJEP testing) is positive, the present professionally qualified person will immediately perform an RT-PCR test for the presence of SARS-CoV-2 virus and send the swab to a laboratory listed in the list of examining laboratories of the State Health Institute.
- 2. The student is then obliged to immediately leave the university premises or other places where education takes place, and the premises of the university accommodation facility; unless otherwise possible, he/she does not have to leave the accommodation facility.
- 3. The student is obliged to inform the provider of health services in the field of general practical medicine about the positive result of the test, by telephone or other usual remote method.

- 4. If the student was tested by a different health services provider, he/she is obliged to inform UJEP about the positive test result
- 5. All people with positive results of the preventive antigen tests are ordered to undergo a confirmatory RT-PCR test for the presence of SARS-CoV-2 virus.

Testing at the health service providers outside of the UJEP premises

The students can make use for testing other health service providers or public testing places, for example:

- 1. Zdravotní ústav (Health Institute) Ústí nad Labem, Moskevská street 1531, 400 01 Ústí nad Labem,
- 2. Sampling point parking area at the winter stadium Masarykova street, Ústí nad Labem,
- 3. Masarykova nemocnice (The Masaryk Hospital) in Ústí nad Labem, o. z., Sociální péče street 3316/12A, 400 11 Ústí nad Labem, T building,
- 4. EUC Klinika (Clinic) Ústí nad Labem, Masarykova street 2000/92, 400 01 Ústí nad Labem, B building, entrance through the parking area,
- 5. Testing places in a place of residence.

Conclusion:

Effective from 24 May 2021 until further notice, the personal presence of students in education (teaching, practice and examinations, if not individual) is allowed only to students who prove themselves with:

- 1. negative results of antigen tests for the presence of the SARS-CoV-2 antigen or RT-PCR tests for the presence of the SARS-CoV-2 virus (the test must not be older than 72 hours or not older than 7 days in the case of the test provided at UJEP), or
- 2. a confirmation issued by a health service provider (SMS) that they have suffered the COVID-19 disease in the last 180 days, or
- 3. a certificate issued by the Ministry of Health that they have been vaccinated against the COVID-19.

When entering UJEP facilities, students must continue to respect current government regulations (use an FFP2 respirator or face mask to cover their mouth and nose, keep distance and accept the maximum number of people allowed at one place).
